#### **Opportunity for Impact**

We are seeking dedicated MAs to join our growing team at ARCx. In this role, you will provide virtual cardiovascular support to our NPs, cardiologists and patients. You will collaborate with multidisciplinary teams to deliver high-quality, personalized care to patients, ensuring seamless coordination of care, top-of-license service, and optimal patient outcomes. You will be at the forefront of transforming cardiovascular care care models for our clients, through telehealth.

A Clinical Specialist MA is responsible for assisting our Virtual NP and Cardiologists in providing care to their patients in the virtual medicine practice, across multiple geographies and offices, to assure high-quality care, care coordination within office clinicians and staff, and efficient service to patients.

## **Primary Duties and Responsibilities**

1. Reviews patients scheduled with Connected Care NP to verify they are appropriately scheduled for Telehealth visit and that all prior visit tasks have been completed by the patient before the appointment date. Communicates with patients about rescheduling needs.

- 2. Completes pre-visit tasks for patient appointments by doing Telehealth with NP prior to the visit. For patients, this includes completing the ambulatory intake form, confirming home medications, and ensuring adequate audio-visual capabilities. Place any orders needed for upcoming visits or future testing at the request of the NP. Updates visit status in IDX. For "no-show" patients, will send a message to the patient in the portal documenting attempts made to reach them for the appointment.
- 3. Completes post-visit tasks for patient Telehealth appointments with NP including sending requests to office staff for support in obtaining medical records/prior author authorization/scheduling of cardiac tests or visits with cardiologists. Sends ambulatory care summaries to patients after appointments are completed via the portal. If the patient is not on the portal, will message office staff to mail these to the patient.
- 4. Triages and responds to messages in the pool.
- 5. Screens Cardiologist and NP messages in their personal inbox and triages as needed.
- 6. Sends clinical messages directly to the NP for medical advice or to clarify the plan. If the Connected Care NP is not available, contact the patient's primary cardiologist for input.
- 7. Schedules same-day/next-day appointments for CC NP. Documents all patient-attempted and completed communication in the medical record.
- 8. Reviews patient charts to obtain needed information to ensure patient data is complete for provider review.
- 9. Proposes lab testing and cardiac testing orders to connected care NP for signature.
